Revision of upper monetary limit for various categories of sanctioning
officers of Police Department-Orders issued.

The Upper monetary limit for sanctioning Temporary Advance / Non Refundable Advance from GPF by various categories of sanctioning authorities have been revised as per the G.O. read above.
02. The upper monetary limit fixed for different categories of sanctioning authorities shall be subject to GPF (K) Rules and delegation of powers granted to the officers.
03. The designation of officers delegated to exercise the enhanced power for sanctioning TA/NRA from GPF at the revised rates as per GPF (K) Rules is given below.
