Hence (i) the following transfer and postings of HC/Cashier/AR Cashier/SA/ISA /HA are ordered with immediate effect, according to their options.

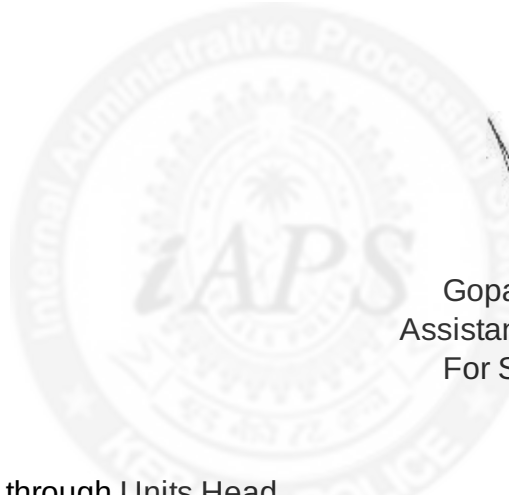
