Considering the request of DGP (Crimes) cited 3rd, he was allowed to continue in CBCID OCW CSO Thiruvananthapuram after effecting his inter district transfer as per order cited 4th.

Now the District Police Chief, Thiruvananthapuram City has reported vide letter cited 5th that, Sri.Lenu V V CPO 2198 of Wayanadu district had been repatriated from CBCID to Wayanadu district and subsequently, he was relieved from Wayanadu district. His present unit is Thiruvananthapuram City.

In the above circumstances, Sri.Lenu V V CPO T 17312 (CPO 2198) of Thiruvananthapuram City is transferred and posted to CBCID OCW CSO Thiruvananthapuram in the existing vacancy of CPO with immediate effect. The DGO referred as 4th above is hereby revised accordingly.
