EXECUTIVE DIRECTIVE No.44/2017

Sub:-Maintenance of BAIL CONDITION REGISTER - Regarding.

The High Court of Kerala and various subordinate Courts grant bail to an accused person in view Sec.437 of the Criminal Procedure Code, 1973 subject to certain conditions like ensuring the attendance of accused before the Investigating Officer on specific day/time for a specific period, etc. In some cases the suspect(s) does not return to the Court at the time of trial. If the accused failed to comply with the bail conditions imposed by the Court concerned, then the failure should be reported by the Investigating Officer to the Court of Law in time through the Government Pleader or through the Public Prosecutor, as the case may be, which may lead to the cancellation of bail. However, on many instances, the Investigating Officer(s) fails to ensure the proper compliance and the due adherence to the orders imposed by the Court while granting the bail.

02. The general register maintained in this regard in the Police Station/CI Office/SDPO is not proper to record whether the accused has appeared before the IP on the particular day/time, whether the IO has noted the same in the Case Diary, whether the accused has violated the condition(s) of the bail, what action was taken against such accused, etc. To overcome all these issues, a register called "Bail Condition Register" in the format appended herewith is to be maintained in every Police Station/CI Office/SDPO to be kept in the custody of the Station Writer concerned so that such instances can be categorized and reported timely before the Court of Law.

03. All DPCs. shall ensure that a Bail Condition Register is maintained by all concerned hereinafter. A weekly report on the entries made in the Register should also be obtained and compiled carefully so that the purpose of keeping of such a Register can be realized.

04. The maintenance of such Bail Condition Register will help us from the attraction of any contempt of Court Proceeding on account of non-reporting/untimely reporting of the violation of the bail condition(s) by the accused.
