ORDER

As per letter read above, Director General of Police (Head of Police Force) & State Police Chief, Kerala has forwarded a request from Dr. N.C.Asthana IPS (KL:1986), Director General of Police who is currently on deputation to CRPF requesting to give him a substantive posting in Thiruvananthapuram and to attach him as Officer on Special Duty (OSD) at Kerala House, New Delhi on compassionate grounds, upon his repatriation to Kerala, in order to continue his daughter's treatment at New Delhi and the State Police Chief has recommended that his attachment at Kerala House, New Delhi as Officer on Special Duty will be beneficial to the Police and the State Government.

2. Eventhough one ex-cadre post of Additional Director General of Police (Modernisation) was created in the Police Headquarters on 23.05.2014, the post is not in operation for a quite long period. Considering the very compelling circumstances as mentioned above, Government are pleased to order that the ex-cadre post of Additional Director General of Police (Modernisation) be revived and Dr.N.C.Asthana IPS, Director General of Police be posted as Additional Director General of Police (Modernisation) against the above revived post in the grade of Director General of Police as a special case on compassionate grounds. The revived post of Additional Director General of Police (Modernisation) is attached to the Kerala House, New Delhi and Dr. N.C.Asthana will be the Officer on Special Duty for liaising and co-ordinating with the Ministry of Home Affairs

and other Ministries of Government of India for the Police Department of the Government of Kerala.
