*Home Department – Police Establishment – Promotions and postings of Officers in the cadre of Deputy Superintendent of Police – Orders issued.*

ORDER

As per the letter read above the State Police Chief has informed that an Oral Enquiry was initiated against Shri.Francis Shelbi.K.F, Circle Inspector of Police (Serial No.2 in the Annexure II) and placed him under suspension vide PHQ order No. G3/189979/2015 dated 18/02/2015 dated 10/11/2015. He was later reinstated into service as per PHQ Order No.G3-189979/2015 dated 18/02/2016.Subsequently Shri.Francis Shelbi.K.F was fully exonerated from the charges levelled against him and the period spent under suspension was regularised as duty for all purpose vide PHQ Order No.G3-189979/2015 dated 25/12/2016. The officer has now submitted a representation requesting to promote him to the cadre of Deputy Superintendent of Police in the light of exoneration of the charges levelled against him.

2) Government have examined the matter in detail and are pleased to promote Shri.Francis Shelbi.K.F, Circle Inspector of Police temporarily who is the most senior officer as per the seniority position reported by the State Police Chief and also considering the administrative exigency to fill up the existing vacancies in the cadre of Deputy Superintendent of Police invoking Rule 31(a) (I) of Kerala State & Subordinate Service Rules and subject to the final verdict of various OAs pending before the Honourable Kerala Administrative Tribunal. On promotion Shri.Francis Shelbi.K.F is posted to District Crime Branch, Thrissur.

3) Following transfer and postings of the officers in the cadre of Assistant Commissioner of Police/ Deputy Superintendent of Police are also ordered with immediate effect on administrative convenience and in public interest.

- 2) Shri.K.M.Jijimon, DySP, Kanjirappally and Sri.Emmanuel Paul, DySP, Mullapperiyar are mutually transferred

The above officers shall join the stations to which they are posted immediately and furnish the Reports of Transfer of Charge to Government without fail. The SPC shall furnish the compliance report of the order to Government within 15 days without fail.
