IPS – TRANSFER AND POSTING OF OFFICERS – ORDERS ISSUED.

ORDER

I. The following ex-cadre posts are created :

- 1.An ex-cadre post of ADGP (Coastal Police) in the scale of pay of Rs 182200-224100 is created for a period of one year and this post is declared equivalent in status and responsibilities to the cadre post of ADGP - crimes under rule 11 of Indian Police Service (Pay) Rules 2007.The cadre post of IGP ,Coastal Police is kept in abeyance.
2. An ex-cadre post of IGP(Ernakulam Range) in the scale of pay of Rs 144200-218200 is created for a period of one year and this post is declared equivalent in status and responsibilities to the cadre post of IGP – Internal Security under rule 11 of Indian Police Service (Pay) Rules 2007.The cadre post of DIG (Ernakulam Range) is kept in abeyance.


