NOTIFICATION

Sealed and competitive quotations are invited by the undersigned for the year 2011-2012, from Driving Schools having valid license / valid certifications from the Motor Vehicles Department, specifying the rates (per trainee) for deputing training staff with vehicles and equipments of the driving schools for imparting instruction in driving to the recruit Constables who are undergoing training at IRB Training Centre, RRRF Camp, Pandikkad, Malappuram (Dist.)

TERMS AND CONDITIONS

1. Quotations should be from Driving Schools having valid license / valid certifications from the Motor Vehicle Department. Valid license / valid certificates should attach along with the quotation.
2. Quotations without valid license / valid certifications from the Motor Vehicle Department will be rejected from the first scrutiny itself.
3. The rate of training for getting motor cycle driving license and light motor driving license (Car/Jeep) may be separately quoted.
4. Instructions should be imparted as per the syllabus prescribed under the Motor Vehicle Act and Rules.
5. It will be necessary to depute properly qualified staff with properly certified instructional vehicles, training equipments, POL and accessories to the IRB Training Centre for the purpose of imparting the above training and no remuneration, other than the quoted rate will be given for this.
6. The rate per trainee will be given only if the trainees pass in the licensing test conducted by the Motor Vehicle Department.
7. Training will have to be given at the times and places as may be decided by the Commandant IR Battalion.

8. The Commandant IR Battalion will have authority to stop the training by instructors from one driving school or engage instructors from other driving school at any time in order to ensure either the quality training or the timely completion of training or the maintenance of proper discipline during training.
9. The Commandant IR Battalion will have the authority to cancel the training conducted by any school without assigning any reason.
10. The instructors deputed by the school will be treated as Guest faculty and are under the general control of the Commandant IR Battalion or of such authority as may be specified by Commandant IR Battalion.
11. The Lowest rate quoted will be accepted and the rate to be fixed and thereafter any qualified Driving School who are prepared to conduct the training at this rate will be entrusted with the work of imparting training. The excess workload beyond the assessed capability of one driving school will be entrusted to the qualified staff of other driving schools limiting payment to the lowest rate accepted.
12. The last date and time for receipt of quotation at 12.00 Noon on 04/06/2011. Opening of the quotation is at 03.00 PM on 04/06/2011 at the Office of the Asst. Commandant & Mentor Trainer, Commando Special Head Quarters, I R Battalion, Pandikkadu, Malappuram – 676522.
